TENANT WATCH

If you wish to check whether a prospective tenant is possibly not desirable to rent to, members are encouraged to search their name on the *Ministry of Justice, Tenancy Tribunal website,* select 'Tribunal Orders' tab.

Tenants who have been brought before the Tribunal and lost will have that decision lodged on the online Tribunal Orders register, it stays there for up to 3 years.

Remember to use a tenancy agreement where tenants are required agree to credit and reference checks. This your first safe guard.

HNZ EVICTIONS FOR METH

Housing NZ has admitted it cannot say how many tenants it removed and blacklisted from state homes last year because of methamphetamine, after initially saying it evicted only five. Its controversial methamphetamine testing programme has been criticised after the Ministry of Health revealed it had repeatedly advised Housing NZ its meth lab guidelines were only suitable for use in former meth labs. Instead, Housing NZ has been using the testing to evict tenants from properties where it was thought the drug may have been smoked, with some individual tenants forced to pay tens of thousands of dollars to clean up the houses. Last week, Housing NZ manager of chemical programmes Charlie Mitchell strenuously denied the Health Ministry had issued any such advice. http://www.radionz.co.nz/news/top/316973/hnz-unsure-how-many-tenants-kicked-out-for-meth - 1 November

HAWKE'S BAY ONCE-SUSPECTED P-CONDEMNED HOUSING STOCK NEEDS TO BE FREED UP

The freeing-up of Housing New Zealand's once-suspected P-condemned housing stock could be a while away yet in Hawke's Bay, despite more than 250 families now on the waiting lists. A Housing New Zealand spokesman said yesterday 50 of its vacant properties were being "prioritised" for being put back into use, but none are thought to be in Hawke's Bay. The spokesman said none were in Napier where the number of families on the waiting list for social housing had increased by more than 20 per cent in the latest quarter, to number 156 at the end of September. http://www.nzherald.co.nz/hawkes-bay-today/news/article.cfm?c id=1503462&objectid=11739316 – 1 November

CHANGES TO TESTING REQUIREMENTS FOR ALL STEEL MESH

The Government has made changes to testing requirements to ensure all steel mesh being sold in New Zealand is up to standard, Building and Housing Minister Dr Nick Smith says. "We're increasing the number of samples which need to be tested, clarifying how that testing is done and requiring testing be done by internationally accredited testing laboratories," Dr Smith says. https://www.beehive.govt.nz/release/govt-strengthens-steel-mesh-testing-rules - 1 November

BILL ENGLISH CAUTIOUS ABOUT DTI RESTRICTIONS

Finance Minister Bill English has given a cautious view on the ongoing discussions with the Reserve Bank of New Zealand about whether the bank should be able to add Debt to Income Multiple restrictions (DTIs) to its Macro-Prudential tool kit for dealing with the financial stability risks created by an over-valued housing market. Last month the Reserve Bank formally asked English to add the DTI tool to its kit, but English's office said he had asked the bank for more information. See **Gareth Vaughan's October 24 article for more detail.** However, English was less than enthusiastic in his first public comments since that confirmation of a formal request, and since QV figures showed earlier this week that Auckland's house price inflation had eased in the last three months since the Reserve Bank applied its third round of Loan to Value Ratio (LVR) restrictions, including a nationwide 40% deposit requirement for landlords. http://www.interest.co.nz/news/84403/finance-minister-cautious-about-reserve-bank-hopes-debt-income-multiple-limits-say - 2 November

INSURERS MAKING IT HARDER FOR PROPERTY OWNERS TO MAKE CLAIMS FOR DAMAGE CAUSED BY METH

Insurers are continuing to revise their policies to make it harder for property owners to make claims for damage caused by methamphetamine contamination. DLA Piper law firm partner, Peter Leman, says insurers are making another round of changes to their policy wordings, as they're being hit with more meth-related claims. They're either limiting, or outright excluding, cover for losses caused by meth damage. Speaking to an insurance industry audience at an Insurance and Financial Services Ombudsman conference, as well as interest.co.nz separately, Leman says insurers are responding to meth like they have to leaky homes in past. "Insurers are looking at ways to ensure their loss commensurate with what they are charging in premium, because the clean-up costs are so extreme," he says. ASB RAISES ALL ITS FIXED MORTGAGE RATES FOR TERMS OF THREE YEARS AND LONGER

ASB has raised all its fixed mortgage rates for terms of three years and longer. This comes as wholesale swap rates have moved sharply higher in the past four weeks. It also comes a month after **ASB raised all its 'special' rates** for terms to three years. Today's (Friday) changes add +20 to +30 bps to all their longer rates. ANZ CEO TALKS ABOUT AUCKLAND APARTMENT DEVELOPMENTS, RBNZ'S NEW LVR RESTRICTIONS AND COMPLEXITY OF POSSI-BLE DEBT-TO-INCOME RATIO RESTRICTIONS

ANZ New Zealand CEO David Hisco says the volume of Auckland apartment developments falling over is not a big issue yet, the Reserve Bank's new LVR restrictions are working well, but the regulator's plan for debt-to-income ratio restrictions will be complex to execute. HOME OWNERS FACE HIGHER MORTGAGE RATES

The Reserve Bank is due to make its last monetary statement of the year, and it is widely expected to cut the official cash rate to a record low 1.75 percent. Despite this, ASB has increased its three-year and five-year standard rates by 0.2 percent and other banks are expected to follow suit. ANZ chief economist Cameron Bagrie told *Morning Report* the higher rates were due to a rise in global interest rates and banks' need for more deposits.

Our monthly Property Focus publication provides an independent appraisal of recent developments in the property market.

THE MONTH IN REVIEW

THE 2016 ANZ PROPERTY INVESTORS SURVEY

Confidence about buying property remains high. The proportion of investors planning to buy more properties rose to the highest since 2009, and investors are optimistic over returns (both capital gains and rental income) for both the year ahead and longer term. In terms of what is keeping property investors up at night, LVR restrictions and other regulatory changes are up there, but are trumped by the risk of damage to property, especially from methamphetamine. While the RBNZ's tightening of the LVR restrictions is certainly causing concern amongst property investors that it will cramp their style, there appears to be little concern that the restrictions could topple the housing market.
