It certainly has been a tough year for investors and landlords. The government has thrown a lot of regulation our way which has made it much harder for us all to provide good quality accommodation.

The lack of interest deductibility is undoubtedly the biggest cashflow hurdle and is having a big impact, especially as mortgage rates rise. Of course, there are other factors as well and as a community, we have our chance for our combined voices to be heard on October 14th, so we strongly encourage you and your family to use your democratic opportunity well.

To that end, I can say that the NZPIF and myself have been active in our response to the impacts and have made our views heard more and will continue to do so leading up to the October general elections.

I have been in parliament meeting with Brook van Velden and expressing our Association's concerns. This was well received and to that end, our July meeting will be a "must attend" meeting with Brooke ven Velden from ACT and Chris Bishop from National being our quest speakers.

Despite the challenges, your committee was worked extremely hard to bring you relevant speakers and we have managed to increase our membership slightly to 324 as at 30 May 2023 which is up by 1 member from last year. This is a commendable effort due to the high attrition rates we are experiencing and also the membership decline affecting a lot of other PIA's and I would like to thank our committee members for their commitment and efforts over the last 12 months.

5. Treasurer's Report

Matthew Underwood presented the 2023 Treasurer's Report.

We are now in a period of stability and in good financial shape.

The start of this year saw the tail of the busy period that included the merger of the two associations and the second yar of the conference preparations that were then abandoned.

You can see three pieces of evidence of that. The first two are in the profit and loss with a few entries for conference and revenue refunds, and conference expenses refunded. We had invoiced NZPIF for the cost to WnPIA of the conference, and they contributed to the invoice, leaving us to write off \$6,660 in profit and loss. You can also see in the statement of movements in equity that we received just under \$40,000 in cash from Capital Property Investors Association last year.

So, after all that, we still made a profit of just over \$3,000 last year.

We also have \$87,000 in the bank. We have a float of some \$27k, and three \$20k term deposits with one rolling over each month.

We are in sound financial shape.

I'd like to thank the Committee for supporting me in managing the financials. Lastly, I'd like to thank Dayna BW for doing nearly all the actual work, including some stuff that is new to her.
